

Farm Waste Management

Most banana farms sit within a Reef catchment, so managing waste correctly protects your property, helps you avoid fines and reduces risks to waterways.

Manage waste by:

- Securing loose waste (including bunch covers) so it can't blow or wash away
- Keeping banana bags and plastics away from riverbanks and flood-prone areas
- Taking waste to your local Transfer Station (check Local Government for locations and fees)
- Burying waste on-farm only in safe areas away from waterways

Workforce Access and Employer Obligations

Understanding your workforce options helps you to stay compliant and find reliable workers. Many growers use local workers, licensed labour hire providers or the PALM scheme, which supplies seasonal and long-term workers from the Pacific and Timor-Leste. Many growers also hire backpackers.

Growers who are Approved Employers invest heavily to employ and manage PALM workers.

If you aren't an Approved Employer, it is illegal to recruit PALM workers, as it risks worker welfare and can impact the community and the industry's social license.

Whichever option you choose, ensure any workers or labour hire companies you engage are licensed, compliant and familiar with banana farm requirements. Seek support and/or report concerns regarding PALM workers via the hotline:

Biosecurity that Protects Your Livelihood AND the Industry's Future.

Panama disease TR4 is here to stay. It kills banana plants and is already present on several farms in Tully. It spreads easily through soil on boots, clothing, equipment and vehicles – often before you even know it's there.

Start clean

Always plant new blocks using tissue-cultured plants from a QBAN-registered nursery.

Reduce the risk

Sharing equipment between farms is one of the fastest ways TR4 spreads. Symptoms may not appear until plants begin yellowing, by then, the disease has already moved.

Once detected, plants within a 5 x 5 metre radius of the infected plant must be destroyed to stop further spread.

Reef Regulations (Cropping and Permits)

Understanding Reef regulations early helps you avoid delays and stay compliant when starting, expanding or moving banana growing activities. Reef protection regulations aim to reduce pollution from farms entering the Great Barrier Reef. If you plan to start, expand, or change to banana growing on land (five hectares or more) without a cropping history in a Reef region, you may need an Environmental Authority (permit).
